For plants treated with RootShield[®], RootShield[®] PLUS⁺ and RSSI

Please fill out the form below and include it with the samples in a separate plastic bag. Sample test results can take as long as two weeks to process depending on in-lab sample volume and timing.

<p>For Plants Grown in Beds Field or Soil Samples</p> <ul style="list-style-type: none">• Take root samples, media samples or soil samples representative of the area treated. Sample may be slightly moist but NOT wet• Process non-treated or control samples first and do not touch them after sampling treated areas• Place each sample in separate, labeled plastic bags, then close securely• Keep roots as undisturbed as possible• If plants are small, include the entire root system• Sample size for roots is about 1 cup of roots• DO NOT WASH THE ROOTS• For media or soil sample, obtain at least a half cup from within the root zone area• Place all samples into labeled zip-lock plastic bags• Pack carefully and keep cool and moist• Ship overnight or 2nd day with ice packs in the shipping container <p>LABEL ALL SAMPLES FOR IDENTIFICATION</p>	<p>For Plants Grown in Pots, Flats or Trays</p> <ul style="list-style-type: none">• Select one or more pots from the growing area• Entire pot can be sent if 6" or smaller• Remove plants in larger pots-cut at soil line• DO NOT WASH THE ROOTS• Place samples individually into heavy labeled plastic bag• Tie up the bag close to the media surface• Pack carefully and keep cool and moist• Ship overnight or 2nd day with ice packs in the shipping container <p>When sampling plugs, send in a full tray 2" pots: send in 10 individually bagged 4" pots: send in 6 individually bagged 6" pots: send in 2-3 individually bagged 9" or 10" pots: send in 2 individually bagged</p> <p>LABEL ALL SAMPLES FOR IDENTIFICATION</p>

Half cup samples from several areas of the bag or pile to add up to two quarts

Minimum of one heaping tablespoon of product in a plastic bag
